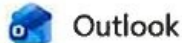

Regarding your second question about why some entries do not include a search reason — this is due to the addition of our new "Offense Type" dropdown field. The Offense Type field is a NIBRS-based, standardized selection that provides the context for the search.

Because Offense Type now captures that information, the separate search reason field is no longer required. As a result, you may see entries where an Offense Type is selected without an additional search reason entered.
